SUBJECT: Establishment of the State Independent Living Council as an Independent Commission

ORIGINATING AGENCY: Office of the Mayor

By virtue of the authority vested in me as Mayor of the District of Columbia by section 422 (6) and (11) of the District of Columbia Home Rule Act of 1973, as amended, 87 Stat. 790, Pub. L. No. 93-198, D.C. Official Code § 1-204.22 (6) and (11), the Rehabilitation Act of 1973, as amended, Pub. L. 93-112, 29 U.S.C. § 701 *et seq.* ("Rehabilitation Act"), sections 108(d) and 110 of the Department on Disability Services Establishment Act of 2006 ("Department on Disability Services Establishment Act"), D.C. Law 16-264, effective March 14, 2007, D.C. Official Code § 7-761.08 (d) and 7-761.10 and 34 C.F.R. § 364.21, it is hereby **ORDERED** that:

I. Purpose

The purpose of this Order is to designate the State Independent Living Council as an independent District of Columbia Commission whose purpose is to promote a philosophy of independent living, which includes consumer control, peer support, self-help, self-determination, equal access, and individual and systems advocacy, in order to maximize the leadership, empowerment, independence and productivity of individuals with disabilities, and the integration and full inclusion of individuals with disabilities into the mainstream of society.

This Order clarifies the role of the State Independent Living Council to include its federally mandated responsibility to ensure proper expenditure of funds and use of resources that it receives under the resource plan. By establishing the State Independent Living Council as an independent District commission, this Order will assure that the State Independent Living Council is in compliance with federal law. In accordance with the Rehabilitation Act, the State Independent Living Council shall be independent of the Department on Disabilities Services/Rehabilitation Services Administration (Designated State Unit) and all other state agencies. The Mayor will continue to make the appointments of all State Independent Living Council members.

II. Role of the State Independent Living Council

The State Independent Living Council shall fulfill the following responsibilities:

1. Develop, sign and submit the State Plan for Independent Living jointly with the Department on Disabilities Services/Rehabilitation Services Administration;
2. Monitor, review and evaluate the implementation of the State Plan for Independent Living;
3. Coordinate activities with the State Rehabilitation Council and other councils that address the needs of disability populations;
4. Disburse and account for any funding made available to the State Independent Living Council;

5. In partnership with the Department on Disabilities Services/Rehabilitation Services Administration, jointly develop and approve the Resource Plan for Independent Living Services;
6. Hire, supervise and evaluate staff and other personnel as may be necessary to carry out the functions of the State Independent Living Council, consistent with D.C. Law, including the D.C. Comprehensive Merit Personnel Act and the District Personnel Manual;
7. Comply with federal reporting requirements, as required by the Rehabilitation Act and 34 C.F.R. Part 370;
8. Perform any act required of, or exercise of any other power granted to, a State Independent Living Council by the Rehabilitation Act as amended and its implementing regulations; and
9. Ensure that all regularly scheduled meetings of the State Independent Living Council are open to the public and sufficient advance notice is provided.

**III. Department on Disabilities Services/Rehabilitation Services Administration
(Designated State Agency)**

The State Independent Living Council shall not be subject to the supervision of a District agency. However, the Department on Disabilities Services/Rehabilitation Services Administration shall provide administrative support to the State Independent Living Council as follows:

1. In conjunction with the Department on Disabilities Services/Rehabilitation Services Administration, develop a plan for the provision of such resources as may be necessary to carry out the functions of the Council;
2. If the resource plan includes staff support for the State Independent Living Council, recognize that the State Independent Living Council shall supervise and evaluate such staff in regards to performance of State Independent Living Council support functions;
3. Disburse and account for any funding made available to the State Independent Living Council, in conjunction with the D.C. Office of the CFO; and
4. Ensure that the State Independent Living Council is operating in accordance with federal and state law, policies and procedures in all of its administrative functions.

IV. Inconsistency with Previous Mayor's Orders

This Order supersedes all previous Mayor's Orders to the extent of any inconsistency.

5. **EFFECTIVE DATE:** This Order shall become effective immediately.


SUBJECT: Appointment – National Capital Planning Commission**ORIGINATING AGENCY:** Office of the Mayor
